

VEHICLE RENTAL AGREEMENT / RECEIPT

This Vehicle Rental Agreement (“Agreement”), under the laws of Singapore, is made between:

ALORIDE PTE. LTD. (UEN: 201629994W) of 31 Alexandra Rd. #05-05 S(159967) (“Owner”); And

Owner rents to Renter and Renter rents from Owner, subject to the terms and conditions of this Agreement:

1. Term. This Agreement shall commence on the day the Renter takes possession of Vehicle until Vehicle is returned to Owner. Renter shall return the Vehicle on the return date, unless the rental period is extended by the Owner OR this Agreement is terminated earlier consistent with the terms herein. If the Agreement is terminated, Renter shall be responsible for returning/towing the Vehicle to the Owner within 24 hours.

2. Payment. Renter shall make payment to **DBS current account 100-904205-2** or at aloride.com/pay (credit/debit card/BTC/PayPal/PayNow). The 1st payment is due immediately upon signing of this agreement.

Renter shall also pay other charges, to the fullest extent allowed by law, including but not limited to:

- All repair cost if the damage is due to Renter’s fault, accident, theft, or unauthorised rider.
- Changing oil/coolant every 1000KM (free at our designated repair shops, or claimable with receipt);
- Unless due to the fault of Owner: All fines, traffic, parking violations, court costs, towing charges and other expenses relating to the Vehicle assessed against the Vehicle during the rental term;
- All expenses incur due to Renter’s failure to return the Vehicle including costs in recovering the Vehicle;
- All costs incurred to collect unpaid monies due;
- Upfront payment to repair the Vehicle and 3rd party insurance excess in case of accident (\$1500 / \$3000);
- Market value of the replacement vehicle if the vehicle is stolen or heavily damaged.
- **\$100** per day fine for late return of the Vehicle or the highest amount allowable under law;
- **\$50** per week fine, or the maximum amount allowed by law, for monies 7 days past due; Payment due for more than 2 weeks will trigger a contract termination at Renter’s fault;
- If rental term is more than 1 month: Early termination fee equals to 1 month of rent.

3. Security Deposit. Renter shall pay a deposit at the time this Agreement is signed. Owner may use the deposit to cover any amounts due under this Agreement or to pay traffic/parking tickets. Security Deposit will be refunded to the Renter within 2 business days after the bike is returned.

4. In case of Vehicle breakdown: Renter shall: (1) Park the Vehicle in a safe place, and place the keys and all documents into its box; (2) Notify the location of the Vehicle to the Owner to arrange towing service (Singapore coverage only). Failure to do so will result in a denial of Renter’s benefit for receiving refund for unused days.

Unless due to Renter’s fault: Owner shall pay for all repair cost. Owner shall then provide a replacement vehicle OR provide a proportional refund for the rental time if the repair time is more than 4 hours. **IN CASE OF ACCIDENT OR THEFT OR DAMAGE CAUSED BY ANY RIDER DURING RENTAL TERM:** This is Renter’s fault under this contract, Renter will have to pay upfront for all repair cost and third party excess. Renter may later claim back these amount from the insurance company if the accident is caused by the 3rd party.

5. Authorised Rider. Only those who sign this Agreement and have a current valid driving license to operate the Vehicle are permitted to use the Vehicle.

6. Condition of Vehicle. Renter acknowledges that Renter has examined the Vehicle and that it is in good condition. RENTER WAIVED ALL OWNER’S LIABILITIES RELATED TO THE CONDITION OF VEHICLE IN CASE OF ACCIDENT. Renter shall get Owner’s consent before any repair or modification to the Vehicle.

7. Termination. This Agreement shall terminate on the date specified in Section 1. Owner reserves the right to terminate this Agreement earlier upon notice to Renter.
